The Surrey Fire Fighters participate in a voluntary payroll deduction program where they donate funds from their pay cheques every pay period. There is nearly a 100% participation rate raising over \$120,000 per year for the Surrey Fire Fighter Charitable Society. The participation extends beyond our fire fighters including Chief administration, Retirees, and Surrey Volunteer Fire Fighters. This make up almost 1/4 of our entire charity revenue.

The Surrey Fire Fighters' Charitable Society have created an avenue for you and your family to consider when planning the future of your estate when you leave us. Ways of Leaving a Gift: Once you have taken care of your family, a gift through your Will to the Surrey Fire Fighters' Charitable Society is a meaningful way to create a family legacy. You may choose to do so in the following ways:

- Sum of funds (e.g. \$10,000)
- Percentage of your estate (e.g. 1%, 10%)
- Residual of the estate, making sure that your family is taken care of first.
- Life insurance policy and have monthly premiums tax deductible.
- Piece of real estate, RRSP's, RRIF's or publicly traded securities

Name Recognition is optional both as a Future Donor and/or Legacy Donor.
